# "7 LOCALISM ACT 2011 – DISCLOSABLE PECUNIARY INTERESTS (DPI's) Members were reminded that at the Statutory Meeting of the Town Council on Wednesday 16 January 2013 the Town Council adopted the recommendations of the Monitoring Officer for the Maldon District in respect of land owned, or property rented, by Members/spouses and the setting of the Annual Precent, by Members who are MDC

Members/spouses and the setting of the Annual Precept, by Members who are MDC Council Tax payers, constituting DPI's. As a precautionary measure, until there is a definitive determination of the above DPI issue by Government Regulation the Town Council was recommended to Resolve as follows: -

"that the Town Council grant a General Dispensation to all Members, in accordance with the pro-forma report set out in the MDC Monitoring Officer's recommendation dated 7 January 2013, as an integral part of the Town Council's Statutory Annual Meeting in May each year and a similar General Dispensation to all Members as an integral part of the Annual Budget Meeting in October/November each year" and it was **RESOLVED: - accordingly."** 

Members are recommended to agree a similar General Dispensation to all Members in respect of the setting of the Annual Precept.

### 11 NOTIFICATION TO MALDON DISTRICT COUNCIL

The District Council set the overall "Tax Base" at its Council Meeting held on Thursday 21 December 2017, it having been considered by the Finance and Corporate Services Committee at its Meeting on Tuesday 28 November 2017.

Maldon District Council has asked that Town and Parish Councils submit their Precept requirements, for 2018/2019, by Friday 12 January 2018.

This information will then be aggregated with the District Council's recommended Council Tax levels as discussed at the Finance and Corporate Services Committee at its Meeting on Tuesday 30 January 2018, and presented to the Council Meeting on Thursday 8 February 2018, at which it will formally set the 2018/2019 District Council Tax levels (including the local precept element from Town and Parish Councils).

The full Council Tax levels (including information from Essex County Council, Essex Fire Authority and the Police and Crime Commissioner) will be set at the Finance and Corporate Services Committee on Tuesday 6 March 2018.
