25 CO-OPTION OF COUNCILLORS

There were no candidates for the by-election called in respect of the casual vacancies in the north ward of the town following the resignations of Councillors Fiona Clegg and Jane English. Councillors are requested to resolve that i) the Town Council co-opt to fill the two vacant seats in the north ward of the town and ii) the notice of co-option be published for a period of twenty-eight days.

RESOLVED: The notice of ordinary vacancy to fill two seats in the north ward of the town be advertisied.

Cllr Stamp advised that advertising needs to be done to encourage residents to join the council.

Cllr Munford asked the criteria for the General Power of Competence, Cllr Stamp informed it is two thirds elected members and a CiLCA qualified clerk.

To discuss and agree the purchase of a web cam to record meetings for the internet, Cllr Bell.

Cllr Stamp suggested looking into the purchase properly. Cllr Donnelly and Cllr Coles will work together and bring to next meeting.
