EALC's bulletin has been released and is attached for your perusal.

Legal Update- Changes to absent vote applications

As of the 31st October, the Elections Act 2022 has introduced new postal and proxy vote regulations, along with an online service for applying for an absent vote. Under these regulations, individuals who wish to vote by post will need to reapply for their postal vote every three years. Additionally, there will be restrictions on the number of people a person can act as a proxy for, with a maximum of four, and no more than two being 'domestic' electors. To enhance the application process, similar to the Register to Vote process, an applicant's National Insurance Number (or other relevant data) will now be verified for all absent vote applications. To accommodate this change, there is a transitional period allowing electors with existing postal or proxy arrangements to adjust and reapply under the new rules. Moreover, a new digital service has been launched today on GOV.UK, enabling electors to apply for a postal or proxy vote online. Although paper applications will still be available, this launch provides electors with an alternative application route.

Sixth Windrush Day Grant Scheme is now open

Councils, community groups and charities can bid for a share of up to £500,000 for educational, arts and sporting projects in the run up to Windrush Day on 22 June 2024.

Grants will fund commemorative and celebratory events and activities in recognition of the contributions the Windrush generation and their descendants have made to UK society. Some previous examples of events funded by the grant include celebratory parades, art exhibitions, and choir groups.

Near Neighbours, a charity that brings people together in communities that are religiously and ethnically diverse, are administering the grant scheme on DLUHC's behalf.

NITROUS OXIDE CLASS C DRUG

As of Wednesday 8 November, it is illegal to possess nitrous oxide for the purpose of getting high and it is now classified as a Class C drug under the Misuse of Drugs Act 1971.

This means that it is now a criminal offence to possess nitrous oxide without a legitimate reason, as opposed to just supply and intent to supply.

Under the legislation, repeat, serious users could face up to two years in prison while those convicted of supply it could face up to 14 years.

Flood Warning Advice from the Environment Agency

Recent weeks have seen a series of extreme weather events as the impacts of Storms Babet and Ciaran continue. While the most significant impacts have been in Yorkshire and the East and West Midlands and along the South Coast, Essex has also experienced severe localised flooding.

Residents are advised by the Environment Agency to enrol in their information services, comprising of maps and targeted alerts, to stay informed about potential weather hazards in your area.

ECFRS- Charging Safety Advice for Electrical Fire Month

Essex County Fire and Rescue Service is issuing safety advice ahead of Electrical Fire Safety Month, after being called to 267 fires caused by electrical devices or chargers in the past 12 months. Andrea MacAlister, Temporary Head of Live Safe, provides tips to avoid charging-related incidents, such as not leaving items charging unattended overnight, using the charger that came with the device, and charging devices on a flat, solid, and stable surface. She also advises people to check their

charger temperatures and replace them with genuine and branded products from trusted suppliers. Lastly, ensuring every level of their property has a working smoke alarm was deemed important, in case of a fire.
